## Commercial Minutes Monitoring

## Background

Our client, a major UK satellite broadcaster, was looking to measure and improve their compliance with a regulatory restriction. The restriction was on the amount of advertising a broadcaster is allowed to show on its channels, in line with the UK regulator's (Ofcom) code on the scheduling, the amount of advertising (COSTA), and the European Audiovisual Media Services (AVMS) directive. The directives establish the need to protect the interests of consumers as television viewers by ensuring they are not exposed to excessive amounts of advertising which could be detrimental to the viewing experience.

#### The Solution

Our approach was to utilise the strengths of iBroadcast as a data aggregation and analysis platform to perform the Commercial Minutes monitoring. We provided a dedicated application that could be plugged in to the iBroadcast product stack to provide the following:-

- Visual alerts for previous, current or future commercial minutage breach via the iBroadcast consolidated user interface
- Automatic notification of breaches via SMS and email, subject to configurable escalation rules
- Cumulative totals for all commercial minutes, in the available schedules
- Full and comprehensive audit trail for previous or current breaches through the iBroadcast user interface
- Notification of missing or invalid schedules

Last minutes changes to the schedule are received and automatically processed handled by the application, ensuring that the checks and results are totally accurate.



The audit trail provides a detailed history of all alerts and can be viewed at any time, providing a permanent record of performance against the commercial minutage directives.

#### The Results

The Commercial Minutes Monitor began to deliver benefits from the moment it went live. Our client has not experienced a single commercial minutage breach, and now has much greater visibility of their compliance performance. This has resulted in significant financial savings and a return on investment (ROI) of 6-8 weeks.
